The project proposal under MKSP for empowering women through sustainable livelihood activities under agriculture in districts of Gujarat was submitted by Gujarat Livelihood Promotion Co. Ltd. After discussions with PIA and Field Implementation Partners, the committee made the following observations:

- 1. The Committee observed that the cost/benefit ratio is very high. The PIA clarified that the ratio has been estimated on the basis of lower limit of possible benefits from the project activities. This doesn't take into account many other qualitative and indirect benefits from the proposed activities. The Committee, therefore, advised the PIA to work out the correct cost benefit ratios in respect of all districts/Field implementation partners.
- 2. The Committee suggested that PIA should focus on chemical free agriculture. PIA can also learn about the best practices from the experience of other States like Bihar and Andhra Pradesh.
- 3. The Committee advised that the PIA should leverage from other Schemes like RKVY for the creation of infrastructure for capacity building component under the proposed project. PIA should focus on Zero Budget Natural Farming.
- 4. The Committee observed that the PIA has adopted demonstration-plot approach which is input-centric and highly subsidized model. This approach is not sustainable and doesn't adhere to the framework of MKSP. The committee has advised PIA to focus on community-centric capacity building approach.
- 5. The Committee has advised the PIA to rework the detailed costing with greater emphasis on capacity building and post-project sustainability.

The Committee advised the PIA to modify and resubmit the proposal.

- 1. The Committee noted that the PIA has good experience in Community mobilization.
- 2. The Committee suggested that the management of project activities should rest with the Women SHGs.
- 3. The Committee also suggested that the PIA should also scale down their project size in the beginning. The successful project may be scaled up in future.
- 4. The committee has observed that the proposed cost per beneficiary is high. The PIA is advised to re-work the costs and propose a low-cost model on the principles of sustainability and scalability.

Based on above observations, the PIA was advised by the Committee to resubmit the project after modifications.
