#### TERMS & CONDITIONS:

- a. Interested parties **may inspect the items physically at CSB Complex, BTM Layout, Madiwala, Bangalore – 560 068** on all working days between 2.00 pm to 5.00 pm.
- b. Those who are interested to participate in the Public Auction should deposit a sum of ₹.5,000/- (Rupees Five thousand only) Demand Draft only in favour of **Member Secretary, Central Silk Board, Bangalore** as EMD **on or before 14/01/2020 upto 4.00 PM** and obtain the acknowledgement/token from this office. The late remittance will not be accepted.
- c. No Parties will be allowed to participate in the Public Auction without submission of the required EMD.
- d. **EMD of the First, Second and third highest bidders will be retained by this office** till the disposal of the articles to the successful bidder. The EMD of other unsuccessful bidders will be refunded after completion of Auction process.
- e. The highest bidder should deposit the 25% of the bid amount on the spot. The remaining balance amount should be deposited within 2 working days after the date of the auction. The highest bidder has to lift the auctioned materials from the said premises within 2 working days (two days) at their own cost. The Central Silk Board is not responsible for any untoward incident once the articles are handed over to the highest bidder.

- f. In addition to this, the highest bidder has to deposit GST @18% of the bid amount **separately** which is required to be remitted to the Assistant Commissioner, CTO, Complex, Koramangala, Bangalore.
- g. In case, the highest bidder fails to deposit the 25% of the bid amount in full on spot or fails to lift the items within the specified date, the EMD and 25% of the bid amount will be forfeited and offer will be given to the next highest bidder.
