Those who are interested to participate in the Public Auction should deposit a sum of Rs. 5000/- (Rupees five thousand only) Demand Draft only in favour of Director, NSSO, Bengaluru as EMD on or before **22-06-2020** up to 4.00 PM and obtain the acknowledgement/token from this office. The late remittance will not be accepted.
- c. No parties will be allowed to participate in the Public Auction without submission of the required EMD.
- d. EMD of the first, second and third highest bidders will be retained by this office till the disposal of the articles to successful bidder. The EMD of other unsuccessful bidders will be refunded after completion of Auction process on the same day.
- e. **The highest bidder should deposit the 25% of the bid amount to Director, NSSO GIA Account No. 1123960033 Central Bank of India IFSC Code CBIN0283975 immediately on the same day (24-06-2020) by 2.00 PM.** The remaining balance amount should be deposited within 02 working days after the date of the auction. The highest bidder has to lift the auctioned material from the said premises within 2 working days (two days) at their own cost. The NSSO, is not responsible for any untoward incidence once the articles are handed over to the highest bidder.
- f. In addition to this, the highest bidder has to deposit GST @ 18% or as applicable on the date of auction, of the bid amount separately which required to be remitted to the Assistant Commissioner, CTO, Complex, Koramangala, Bengaluru.
