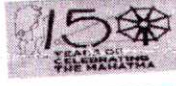

TERMS AND CONDITIONS FOR DISPOSAL OF OLD VEHICLES THROUGH PUBLIC AUCTION

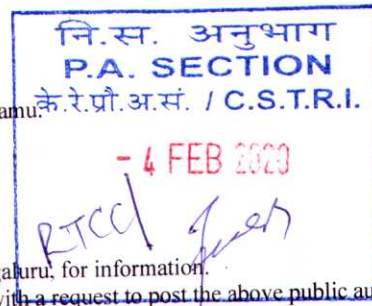
1. Every participating bidder has to submit his/ her identity proof (Voter/Aadhaar/ PAN card) before participating in the public auction process.
