
1. Interested Firms/persons may inspect the said vehicle physically on any working days from Monday to Friday between 02.00 PM to 4.30 PM at the above mentioned office premises.
2. The disposal of vehicles shall be strictly on "**AS IS WHERE IS CONDITION**" and no guarantee of quality or certificate of its worthiness will be given by the Central Silk Board.
3. Firms/Persons who are interested to participate in the auction should deposit an **EMD amount of Rs.2,000/- (Rupees two thousand only)** in the Form of **DD/Banker's Cheque only** drawn in favour of "The Director, SBRL, Bangalore" on or before **03.11.2020 (TUESDAY) upto 10.00 AM** and obtain proper acknowledgement. **The EMD will not be accepted beyond the prescribed date & time.** EMD will not bear any interest.
4. The bidder has to provide his full Name/Name of the authorized signatory of the Firm/Name of Father, Full Postal Address, Telephone Number and Mobile Number before participation in the auction process.
5. No parties will be allowed to participate in the public auction without submission of the required EMD.
6. **No documents like RC BOOK, INSURANCE, TAX CARD etc., of the vehicle will be given to highest bidder since said documents are cancelled by RTO and treated as COMPLETE VEHICLE AS SCRAP.**
7. EMD of the First, Second and Third highest bidders will be retained by this office till the disposal of the vehicles to the successful bidders. The EMD of other unsuccessful bidders will be refunded after completion of the auction process.
8. The successful bidder should deposit 25% (Twenty-fivePercent) of the bid amount on the spot either by Cash or in the form of DD/Banker's Cheque drawn in favour of The Director, SBRL, Bangalore.The balance amount should be deposited within 3 (Three) working days after completion of the auction in the same form of payment as mentioned above. If he fails to deposit the balance amount within the stipulated time of 3 (Three) working days, the 25% amount so deposited will be forfeited along with the E.M.D.

9. The Successful Bidder should remit 25% of the Bid Value **on spot** including the GST (i.e.) CGST 9% and SGST 9% on the bid amount at the time of depositing.
