TERMS & CONDITIONS FOR DISPOSAL OF DEAD STOCK ARTICLES THROUGH TENDER CUM PUBLIC AUCTION:

- Interested parties may inspect the "Dead Stock Articles" at Regional Office, Central Silk Board, CSB, Officer's Flat, 96/40, Bailey Road, Patna-1 in all working days between 10.00 AM to 5.00 PM.
- Earnest Money Deposite (EMD) of Rs. 200.00 (Rupees two hundred only) in the form of Demand Draft drawn in favour of Regional Development Office payable at Patna should be accompanied along with the tender.
- Sealed tenders, addressed to the Assistant Secretary (Tech.), Regional Office, Central Silk Board, Officer's Flat, 96/40, Bailey Road, Patna – 1 should be submitted, super scribing the disposal of "Dead Stock Articles" on the left side top of the envelop to reach this office by 12.00 noon on or before 06.07.2020..
- No tender will be accepted on any ground, what so ever, after the due date and time with EMD.
- Simultanously public auction of the above said Dead Stock Articles will also be conducted on 06.0%.2020 at 1.00 PM in the office of Regional Office, CSB, Officer's Flat, Bailey Road, Patna-1 and interested parties may participate after registration of their name by paying the above said EMD.
- Parties, who have submitted tenders with required EMD and wish to participate in public auction also, should separately tender the required EMD amount in cash, before the commencement of auction.
- No parties will be allowed to participate in the public auction without payment of the required EMD.
- After completion of public auction, the sealed tenders received before the due date and time will be opened in the presence of both tenders and bidders, who choose to be present.
- Only highest bids amount of tender received of public auction, which are more advantageous to the Board will be accepted.
- The highest auctioneers should be deposite 25% of the bid amount by cash on the same day immediately after the auction proceedings where as, in cash of highest tenders who are not present in the public auction proceeding should deposite the above said amount immediately on intimation from this office, failing which their EMD will be forfeited.
- EMD/ Caution Money Deposite will not carry any interest.
- Dead Stock Articles will be handed over the successful bidder only after approval of the Competent Authority which will be intimated in due course.
- The successful bidder has to pay the full and final amount of the bid value along with the sale tax applicable within one week from date of intimation from this office, failing which their offer wll be treated as cancelled besides forfeiture or 25% of money and EMD deposited earlier.
- EMD of the first and second highest bideer/ auctioneers will be retained at this office till
 the disposal of the dead stock articles to the successful bidders.
