Terms & Condition :-

1. The interested parties may inspect the said vehicle physically on any working day from Monday to Friday between 3.00 PM to 5.00 PM.
2. The disposal of vehicle shall be strictly on "**AS IS WHERE IS CONDITION BASIS**" and no guarantee or certificate of its worthiness or quality will be given by CSTRI.
3. Firm/person who are interested to participate in the auction should deposit EMD amount of **Rs.2000/=** (Rupees Two Thousand only) **by way of Cash** on **21.02.2024** between 10.00 am to 10.50 am and obtain proper acknowledgement. The EMD will not be accepted beyond the date and time of auction and will not bear any interest.
4. No parties will be allowed to participate in the public auction without submission of the required EMD.
5. EMD of the first, second & third highest bidders will be retained by this office till the disposal of the vehicle to the successful bidders. The EMD of other unsuccessful bidders will be refunded after closure of auction.
6. The successful bidder should deposit 25% [twenty five percent] of the bid amount in spot either in cash/DD/Banker cheque drawn in of Director, CSTRI, Bangalore. The balance amount should be deposited along with applicable taxes within 03 working days after completion of the auction in the same form of payment.
7. The delivery of the said vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status [Ration Card / Voter Identity Card or Aadhar Card etc. in case of individual and Registration Certificate in case of firms etc.

8. The disposed/scrapped vehicle should be lifted by the successful bidder(s) within 48 hours depositing the money at his own expenses. No assistance / transportation will be provided by CSTRI. Permission to take out the disposed scrap vehicle from CSB complex will not be allowed on General Holidays, Saturdays & Sundays etc.
9. No documents like RC Book, Insurance, Tax Card etc. of the vehicle will be given to highest bidder since the said documents are already cancelled by RTO and treated the said vehicle as full scrap.
10. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number and mobile number.
11. If the highest bidder/highest quoting firm fails to honour the bid, the contract will be forfeited. In such case an opportunity shall be given to the second highest quoted bidder to complete the bid, provided if he accepts the price offered by the H-1 party. In case of any dispute, decision of the Director, CSTRI, shall be final.
12. Applicable GST will be collected from the highest bidder.
13. CSB Employees should not participate in the auction.
