1. Interested Firms/persons may inspect the said vehicle physically on any working day from Monday to Friday between 2.00 PM to 5.00 PM at the above mentioned office premises.
2. The disposal of vehicle shall be strictly on "**AS IS WHERE IS CONDITON BASIS**" and no guarantee or certificate of its worthiness or quality will be given by CSTRI.
3. Firm/person who are interested to participate in the auction should deposit EMD amount of Rs.1000/- (Rupees one thousand only) by way of Cash/DD/Banker's Cheque drawn in favour of Director, CSTRI, Central Silk Board, Bangalore on or before 14.09.2020 at 11.00 AM and obtain proper acknowledgment. The EMD will not be accepted beyond the date and time of auction and will not bear any interest.
4. No parties will be allowed to participate in the public auction without submission of the required EMD.
5. EMD of the first, second and third highest bidders will be retained by the office till the disposal of the vehicle to the successful bidders. The EMD of other unsuccessful bidders will be refunded after closure of auction.
6. The successful bidder should deposit 25% (twenty five percent) of the bid amount on spot either in the form of Cash/DD/Banker cheque drawn in favour of Director, CSTRI, Bangalore. The balance amount should be deposited along with applicable taxes within 03 working days after completion of the auction in the same form of payment.
7. The delivery of the said vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card or Aadhar Card etc. in case of individual and Registration Certificate in case of firms etc.)
