ORDER

Sub: Implementation of the Orders dated 04.02.2021 of the Hon'ble High Court of Karnataka, Bangalore in Writ Petition No.31831-64/2019(S-CAT) filed by the Central Silk Board - regarding.

Ref: Intimation No.CSB-63(155)/2021-ES.II dated 22.03.2021 posted on the Central Silk Board Website

While disposing of the Writ Petition No.31831-64/2019(S-CAT) filed by the Central Silk Board vide Order dated 04.02.2021, the Hon'ble High Court of Karnataka, Bangalore in the operative portion of the judgement has given the following directions:-

"16. More so, it is needless to mention not only the present employees, but all the other employees who are holding the post of Technical Assistants in the Central Silk Board will be entitled for the same higher pay scale of Rs. 5,000 - 8,000 with effect from 1.1.1996. The Central Silk Board is directed to ensure that the aforesaid pay scale is paid to all the concerned within a period of thirty days from the date of receipt of this order. In case, if the amount is not paid along with arrears, each and every employee holding the post of Technical Assistant shall also be entitled for interest and the same shall carry interest at the rate of 8.5% p.a., from the date of entitlement till the amount is actually paid to them,"

2. In compliance to the directions of the Hon'ble High Court of Karnataka, Bangalore, it has been decided to implement the said Orders dated 04.02.2021 in Writ Petition No.31831-64/2019(S-CAT) in respect of all the employees holding the post of Technical Assistant in the Central Silk Board w.e.f. 01.01.1996 including the Respondents from 1 to 33 in the said Writ Petition. At the time of implementation of the recommendations of the Cadre Review Committee with regard to rationalisation of pay scale, the employees working in the cadre of Technical Assistant were granted the revised pay scale of Rs.5000-150-8000 (pre-revised) w.e.f. 15.11.2001. In terms of the above Orders dated 04.02.2021 passed by the Hon'ble High Court of Karnataka, Bangalore, the effective date of placement of the employees holding the post of Technical Assistant in the Central Silk Board in the pre-revised pay scale of Rs.5000-150-8000 has been advanced to 1st January 1996.

3. Accordingly, the pay of all the concerned employees (as per list enclosed) will be fixed in the pre-revised pay scale of Rs.5000-150-8000 w.e.f. 01.01.1996. Consequent on pay fixation, they are eligible for arrears of pay. They are advised to exercise the option for fixation of pay under FR23 Government of India decision 6 thereto and FR 22 [1] [a] [2] in the pre-revised pay scale of Rs. 5000-150-8000.
