## TENDER CUM AUCTION NOTICE

It is hereby notified that the Scientist-D, Research Extension Centre, CSR&TI, Central Silk Board, Vikarabad 501 101 interested for auction of 28 *Eucalyptus* trees by calling competitive bids through registered post on 'As is where is basis'.

### **Terms and Conditions:**

The interested parties can inspect the trees during office hours on any office working days. They may submit their highest bid under sealed cover duly superscribed as "Bid for trees' on the top of the envelope so as to reach this office on or before 12.01.2022 through Registered Post. Hand delivery of the bid shall not be accepted.

The security money of Rs 10000=00 should be deposited in the form of Demand draft alongwith with their bid favouring 'Director, CSRTI, Vikarabad'. The security money shall not bear any intrest and will be refunded to the unsuccessful bidders by cheque/online in due course.

Duly sealed bids received upto 2.00 PM on 12.01.2022 will be opened on same day at 3.00 PM in presence of the bidders, if any, present at that time in the office premises of REC, Vikarabad. In case 12.01.2022 is declared as a holiday etc for any reason, bids will be opened on the next working day at the same place and time.

The DFO, Vikarabad has already accorded permission for felling of 28 *Eucalyptus* trees vide RC No. 1738/2021/AS Dt. 03.12.21.

The highest bidder shall have to take delivery of the trees within 20 days from the date of opening of the bids after making full payment of the bid amount in the

form of cheque or online payment favouring 'Director, CSRTI, Vikarabad' payable at Vikarabad failing which Security Money deposited shall be forfeited.

This office shall not be held responsible for any loss to the auctioned material after the auction procedure is over.

It should be ensured that there should be no damage to the Govt property while cutting or carrying the auction material. If Govt property is damaged while cutting or carrying the auctioned trees, the successful bidder shall be held responsible.
