With reference to above subject, this office had called for rate quotations on 19/04/2024 for hiring one vehicle (with yellow board) for CPP activities in Kolar Mega cluster for 2024-25 on monthly basis as follows:

Name of the cluster	Total Maximum Kilometers in a Month
Shapur (Kolar Taluk), Yeldur (Srinivasapura Tq), Kurudumalai (Mulabagal Tq), Tekal (Malur Tq), Ithandahalli (Bangarpet Tq) & Siddlaghatta (Sidlaghatta Tq) Total: 6 Clusters	3500 km (To cover all the 6 clusters)

The vehicle is required for a long term programme for the **financial year 2024-25 (July 2024 to March 2025)** and the following terms and conditions will apply:

- Hiring of vehicle is on Kilo Meter basis only.
- Total no. of days the vehicle is required in a month-**20** days (approx.)
- Monthly **maximum** usage will be 3500 KM in the above given area. However the number of KMs may vary, and payment will be based on the **number of KMs used in that month.**
- If usage extends as specified above, it will be charged on KM basis and if the usage exceedshours, the excess duration shall be paid on hourly basis.
- The rate quoted shall be **including** driver bata, Toll fees, taxes etc.

6. The hired vehicle shall **not be older than 5-8 years** and should **have yellow board** and also should be in good running condition.
7. In case of break down, the vehicle shall be replaced in less than 24 hours at the cost of the service provider.
8. The authority reserves the right to terminate the contract, if the services are not satisfactory leading to hampering the official work.
9. The vehicle shall run from the Head Quarter of the Kolar Mega cluster (REC Madivala) and movement of the vehicle is restricted to only cluster area, unless otherwise officially required.
10. The vehicle and the driver should have valid documents such as **Aadhaar Card/PAN, valid Driving license, RC Book, Emission Test Certificate, vehicle insurance, tax paid receipts** etc.
11. The competent authority will finalize on hiring of vehicle.
12. Quotation should be sent by **Registered post/ Speed Post** only.
13. The vehicle provider should have **PAN number** registered under **CGST & SGST, TDS, will be effected at the time of payment under the Rule 194-c of TDS rate chart.**
14. After issuing the vehicle approval for hiring, agreement to be made up to **March 2025 (ie., from July 2024 to March 2025)** with vehicle provider to provide the vehicle for the agreement period only. If discontinued to provide vehicle, the penal charges to be framed against the vehicle provider @ 10%.
15. The undersigned reserves the right to reject in part or in full any quotation which will not comply with the Terms & Conditions.

Since no quotations were received till the last date of 14-05-2024, the last date for receipt of quotations is extended upto 25-05-2024.
