

The sealed quotation should be superscribed as “**Quotation for purchasing FABRIC AIR PERMEABILITY TESTER**” not to be opened on or before **07.02.2024 11.00 a.m.** The last date for submission of bids is 07.02.2024 upto 11.00 a.m. The bids will be opened on **07.02.2024 at 11.30 A.M.** The quotations received after the due date and time will be rejected summarily.
2. The quotations (single bid) should be sent in single Bid system in sealed cover duly superscribed as “**Quotation for supply of Fabric Air Permeability Tester**”.
3. The rates quoted should be valid for 180 days. The equipment should be supplied within **45 days** from the date of purchase order.
4. The equipment should be supplied to **The DIRECTOR ,CENTRAL SILK TECHNOLOGICAL RESEARCH INSTITUTE, CENTRAL SILK BOARD COMPLEX,B.T.M. LAYOUT, MADIVALA, BANGALORE – 560 068**
5. The bidder should furnish undertaking that **Fabric Air Permeability Tester** to be supplied shall match with the specifications mentioned above. The bidder has to furnish the basic rate, excise duty (if any), GST (if any), Freight Charges including Insurance (if any), Packing & forwarding charges (if any) Erection & Commissioning charges(if any)

7. The Supplier shall provide Warranty/Guarantee valid for a minimum period of 12 months from the date of installation of machine. Any defects noticed in the machine which is unintentional shall be set right by the supplier at free of cost for good performance of the machine.

12. No advance payment will be made. The payment will be released only after delivery of the equipment in good condition as per our specification, Erection and commissioning
13. Admissible GST-TDS will be deducted while effecting the final payment.
