**TERMS & CONDITIONS:**

1. The sealed quotation in two bid system should be submitted to the DIRECTOR, CENTRAL SILK TECHNOLOGICAL RESEARCH INSTITUTE, B.T.M. LAYOUT, MADIWALA, BANGALORE – 560 068. The quotation should be superscribed as "Quotation for supply of 25Kg/hr. Cap. Electric Steam Boiler" – not to be opened on or before 17.05.2022 3.00 p.m". The quotations received after the due date and time will be rejected summarily.
2. The quotations should be sent in two parts i.e., **Technical Bid and Financial Bid** separately in a sealed cover duly superscribed and both these covers put in a bigger cover which should also be sealed and superscribed.

**(I) Technical bid should contain the following informations with documentary proof.**


- a) The Agency is ready to supply the equipment / machinery as per the above specifications.
- b) The Agency should submit the details of technical support, after sales service and annual maintenance etc.,
- c) The technical bid which does not fulfil the above conditions will be treated technically non-responsive and summarily be rejected.

(II) **Financial Bid should contain the following information's with documentary proof.**

- a) Financial Bids should consist of **UNIT PRICE**, Excise Duty, Insurance, Packing & Forwarding, Erection & Commissioning, Transportation charge & GST ,
  - b) The total price quoted by the Agency should be **valid for 180 days** from the date of quotation.
  - c) The Agency should agree to give warrantee for a period of 12 months from the date of supply.
  - d) Price quoted should be FOR destination.
  - e) The Financial bid which does not fulfil the above conditions will be treated financially non-responsive and summarily be rejected.
3. The bidder should submit the duly filled **Bid Securing Declaration** form alongwith the quotation (as per the format enclosed) in lieu of EMD.
  4. The last date for submission of the sealed quotation is **17.05.2022 at 2.00 p.m.** The quotations will be opened at **3.00 p.m.** on the same day in the presence of the representatives who choose to be present.
  5. No advance will be paid. However, payment will be released within 30 days after receipt of the item in good working condition and conform to the specifications, **Erection and commissioning.**
  6. The Supplier shall provide Warranty/Guarantee valid for a minimum period of 12 months from the date of installation of the equipment. Any defects noticed in the equipment which is unintentional shall be set-right by the supplier free of cost for good performance of the equipments.
  8. The Director, CSTRI, Bangalore reserves the right to accept any quotation or reject all the quotations without assigning any reason thereof. The decision of the Director is final and no correspondence will be entertained from any party in this regard.
  9. PAN /TIN/GST number issued by the concerned Departments should be indicated.
  10. Liquidated damages for delay & non supply @ 0.5% will be deducted from the bill per week for not supplying the item within the stipulated time subject to a maximum of 10% of the total cost of the equipment
  11. The successful bidder should supply the ordered equipment to CSTRI, Bangalore within 30 days from the date of issue of supply order
