Competitive sealed quotations are invited from the interested parties to supply the **FARM YARD MANURE** as per the specifications mentioned below for the use of this centre.

**FARM YARD MANURE to supply 12.00 Metric Tons during Feb/ Mar, 2022**

(The Farm Yard Manure/ decomposed cow dung should be of not more than 30% of moisture and free from soil, sand, stones, plastic materials, other foreign objects etc. The rate should include the loading, un- loading, transportation and the weightment of the load with weight slip at the time of supply).

### **TERMS AND CONDITIONS:**

1. The successful bidder should be ready to supply the Farm Yard Manure in the month stated above, at the same rate quoted by him. He should produce the Farm Yard Manure weightment slip for the conformity of the quantity supplied.
2. The rates should be excluding taxes and other Govt. levies. The taxes and other Govt. levies should be mentioned separately with % where such taxes are applicable.
3. The quotations must contain the detailed information on the quantity, quality, loading/ un-loading and transportation charges etc.,
4. The envelope containing quotations should be sealed and super scribed as “Quotations for supply of FARM YARD MANURE” and the envelope received without the superscription and seal will be summarily rejected.
5. The last date and time for receipt of the quotations is **02-02-2022 till 3.00 PM** and the quotations received after the due date and time will be rejected.

6. The quotations will be opened on the same date i.e. on **02-02-2022 at 4.00 PM** at this office, in presence of the tenders or their authorized representative who desire to be present.
7. The payment will not be made either in cash or in advance. The party interested to quote the rates should supply the FARM YARD MANURE on credit basis.
8. The rates quoted by the party must be valid up to 120 days
9. The payment of the bill will be settled promptly but only on receipt of the material as specified above and the material will be rejected if found not in accordance with specifications.
