- 7 After completion of the Public Auction, the submitted sealed tenders will be opened in the presence of the tenderers / participants of the public auction. The highest bid amount arrived therein i.e., in the Tender / Public auction, will be final and no further bidding process will be entertained. The decision of the committee supervising the auction process will be final and binding on all the participants.
- 8 The bidder who would like to participate in the Public auction has to get themselves registered by paying the EMD and a Register number will be given to them. The bidder who pays the EMD amount will only be allowed to participate in the public auction.
- 9 The highest bidder should deposit 25% of the bid amount by Cash/Digital payment on the same day, immediately after the tender-cum-public auction proceedings, if present, or immediately after receipt of intimation from this office failing which their EMD will be forfeited.
- 10 The EMD submitted does not carry any interest and will be returned soon after completion of the auction proceedings.
