

With reference to the subject cited above, I am to inform that this Institute intends to convert totally 144 kgs of Different fibres to produce 75 kgs of Spun yarns approximately having 2 types of English counts Viz 12s/20s as per spun yarns of following technical specifications:

- The above Silk Blending and Spinning work have to be done in a systematic manner by following Blending norms as the compatibility of Staple length and fiber denier have to be considered to ensure proper blending of silk with cotton, Viscose, Lyocell and banana fibers. Primarily the factory which is having facilities/ machineries like Blow Room (very essential for blending), carding, drawing, simplex, ring spinning, reeling and cone/bobbin winding to supply the spun yarn in cone form.
- As indicated above, 144kg of Fibres of different variety will be supplied at your doorstep for spinning different counts at optimum process efficiency in English count system
- Spinning of all the samples on the same set of machinery to avoid influence of machine variations on yarn properties.
- Spinning work to be initiated without undue delay immediately upon receipt of work order.
- Spinning activity to be completed within a short time frame to ensure minimum influence of environmental / working conditions on spinning performance.
- Spinning process optimization according to the input material which may have short fibre length.

You are requested to quote your lowest rate for the above said work to this Institute. The Terms & Conditions are as below:-

TERMS & CONDITIONS

The quotation should be superscribed "QUOTATION FOR CONVERSION CHARGES FOR SILK BLENDING SPINING WORK" with the enquiry letter number and date of the opening of the quotation.
- 2. Applicable taxes, if any, must be indicated in the quotation separately. The finished product will be collected by this office at the door step of the lowest bidder.
- 3. The finished materials should be made ready within 30days from the date of work order.
- 4. The rate quoted by the firm should be valid for 120 days from the date of opening of the quotation.
- 5. The last date for submission of the sealed quotation is 17.10.2022 at 2.00 p.m. The quotations will be opened at 3.00 p.m. on the same day in the presence of the representatives who choose to be present.
