With reference to the subject cited above, this office requires (BOLERO/ Scorpio) for CPP cluster Development Programme Nanded area activities in Kilo Meter basis for long term programme with the following term and condition from July, 2024 To March, 2025

1. Hiring Vehicle on Kilo Meter basis.
2. Total no. of days of the vehicle required in a month-9 days.
3. Monthly usage will be 2000 KM or 120 hrs duty
4. However number of KMs may vary and payment will be based on the number of KMs used in that month.
5. The rate quoted shall be all inclusive including driver batta, toll free, taxes etc.
6. The hired vehicle shall not be older than 5-8 years, should have yellow board and in good running condition.
7. In case of breakdown, the vehicle provider shall replace the vehicle within 24 hours at the cost of the service provider or will be adjusted on monthly rental of the vehicle.
8. The authority reserve the right to terminate the contract if the services are not satisfactory and hampers the official work
9. The vehicle shall run from the cluster headquarter and movement of the vehicle restricted to only cluster area.
10. The vehicle and the driver should have valid document such as Aadhar card, PAN, Valid driving license, RC Book, Emission Test Certificate, Vehicle insurance etc.
11. The Competent authority will finalize on hiring of vehicle.
12. The quotation should be sent by Registered post/Speed post only.

13. The vehicle provider should have PAN number registered under CGST & SGST TDS (Tax Deduction at source) will be effected at the time of payment under the rule 194-C of TDS rate chart.
14. After issuing the vehicle approval, for hiring, Agreement to be made up to march, 2025 with vehicle provider to provide the vehicle for the agreement period only. If discontinued to provide vehicle the panel charges to be framed against the vehicle provider @ 10 %
