Terms & Conditions are as follows:

- 1) No. of days vehicle is required in a month -20 days.
- 2) Monthly minimum usages is 1500 KMs and 200 Hours of duty.
- 3) If the usage extends 1500 KMs /Month, the excess mileage will be paid on Kilometre basis and similarly if the usages exceed 200 hours, the excess duration will be paid on hourly basis.
- 4) Monthly rate quoted should include Driver allowance, Taxes, etc if any.
- 5) The Vehicle shall be in good running condition and it shall not be older than 5 8 years.
- 6) The hired vehicle shall be stationed at Vikarabad/Zahirabad for the exclusive use of the Extension Activities of REC Vikarabad.

- 7) In case of break down, the vehicle shall be replaced in less than 24 hours at the cost of the vehicle provider.
- 8) The vehicle and the Driver shall have valid Documents/ such as ID card of the driver/ valid license, RC Books Emission Test Certificate, Vehicle Insurance Driving Licence respectively.
- 9) TDS (Tax Deducted at source) will be deducted @ 2% in case of partnership/@ 1 % in case of individual if the vehicle provider has PAN No. otherwise TDS recovery will be @ 20% as per the Income Tax Act.
- 10) The vehicle provider should have PAN number etc.

Interested parties may submit their lowest quotation. - 5) Owner if the vehicle should be ready to replace the Driver within 24hours, if he is found unfit for driving the vehicle or due to in-disciplined behaviour towards In-charge or the staff of REC, Vikarabad.
- 6) Tentative duration of Extension activities programme will be approximately 1 year.
