(i) Holding analogous posts on regular basis or with 5 years regular service in the Pay Matrix Level-11, Rs. 67700-208700/- B). Possessing the essential qualifications and experience prescribed below:-

- 1) Master's degree in Urdu of a recognized University or equivalent.
- 2) 10 years experience in publication work including experience of research/teaching, editorial and translation work, technique of printing and production of books.

Desirable:- Preference will be given to the candidates possessing qualification M.A. in Arabic or Persian.

2. Research Assistant (RA):- Essential: 1. Master's degree of a recognized University or equivalent. 2. Must have taken Urdu as an optional subject at the graduation level for 3 years/2 years degree course in case of M.A. or must have taken Urdu as a second language upto 2 years or 3 years degree in case of M.A./M.Sc./M.Com or must have taken Urdu at High School/Higher Secondary School level in case of M.Sc./M.Com where offering Urdu as a second language at degree level is not provided. 3. 3 years experience of teaching or terminological and/or translation/editing work in Urdu/Library Science/Distance Education.
