

**2.1(24) Confirmation of Minutes of the 1<sup>st</sup> BOA (2024 Series) meeting held on 06.02.2024.**

The BOA ratified the Minutes of its 1<sup>st</sup> Meeting (2024 Series) of the Board of Approval for EOU Scheme held on 06.02.2024.

**2.2(24) Proposal for extension of validity of LOP from 03.02.2024 to 02.02.2025 - M/s Sai Saran Technologies Pvt. Ltd., EOU under MEPZ.**

The Board, after deliberations, **approved** the proposal of the unit for extension of LoP for one year i.e. from 03.02.2024 to 02.02.2025 subject to the provisions laid down in FTP 2023 read with HBP 2023.

**2.3(24) Proposal for conversion of existing DTA to EOU unit - M/s Intas Pharmaceuticals Limited under KASEZ.**

The Board, after deliberations, **approved** the proposal of the unit for conversion of existing DTA unit subject to the condition that the unit's export obligation under advanced authorisation will be carried over, if it has a valid export obligation period. The unit have to pay duties, interest and penalty as applicable, in respect of items whose export obligation period has expired under advance authorization cases as per present provisions of FTP and HBP.

The board also **approved** the additional location of the existing DTA unit subject to the condition that there are no diversions on the way between DTA unit and its additional location, record based controls for movement of goods – whether raw material or finished goods should be done under challan documents as well as any other format procedure which Development Commission may decide in consultation with Jurisdictional Customs/ GST Authorities.
