NOTIFICATION

S.O. 2706(E).- WHEREAS M/s. Gujarat Industrial Development Corporation, a state industrial promotion organisation in the State of Gujarat, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act) to set up a sector specific Special Economic Zone for biotechnology sector at Biotech Park, Savli GIDC Estate, Village Manjusar, District Vadodara in the State of Gujarat;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the above Special Economic Zone on the 23rd June, 2007;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones, Act 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006:-

(i) the Central Government hereby notifies the following survey numbers with area given below in the Table, as a Special Economic Zone, namely:-
